เรื่อง การออกหนังสือรับรองถิ่นกำเนิดสินค้าตามความตกลงว่าด้วยการค้าสินค้าภายใต้กรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจที่ครอบคลุมด้านต่าง ๆ ระหว่างรัฐบาลแห่งกลุ่มประเทศสมาชิกสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้และสาธารณรัฐเกาหลี

ตามที่ได้มีประกาศกรมการค้าต่างประเทศ เรื่อง การออกหนังสือรับรองถิ่นกำเนิดสินค้าตามความตกลงว่าด้วยการค้าสินค้าภายใต้กรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจที่ครอบคลุมด้านต่าง ๆ ระหว่างรัฐบาลแห่งกลุ่มประเทศสมาชิกสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้และสาธารณรัฐเกาหลี พ.ศ. ๒๕๕๘ ลงวันที่ ๒๒ ธันวาคม พ.ศ. ๒๕๕๘ กำหนดแนวปฏิบัติในการออกหนังสือรับรองถิ่นกำเนิดสินค้า (Certificate of Origin: Form AK) ภายใต้ความตกลงดังกล่าวเพื่อประกอบการใช้สิทธิพิเศษทางภาษีศุลกากร สำหรับสินค้าที่มีถิ่นกำเนิดและส่งออกจากประเทศไทยไปยังประเทศสมาชิกอาเซียนหรือสาธารณรัฐเกาหลี และต่อมาคณะอนุกรรมการว่าด้วยภาษีศุลกากรและกฎว่าด้วยถิ่นกำเนิดสินค้าอาเซียน - สาธารณรัฐเกาหลี (ASEAN-Korea sub-Committee on Tariffs and Rules of Origin: AKSTROO) และคณะกรรมการดำเนินงานความตกลงเขตการค้าเสรีอาเซียน - สาธารณรัฐเกาหลี (ASEAN - Korea Free Trade Area - Implementing Committee: AKFTA - IC) ภายใต้ความตกลงดังกล่าว ได้มีมติร่วมกันในการประชุมครั้งที่ ๒๒ เมื่อวันที่ ๑๐ มิถุนายน พ.ศ. ๒๕๖๘ เห็นชอบการปรับโอนพิกัดอัตราศุลกากรของกฎเฉพาะรายสินค้า (Product Specific Rules: PSRs) จากระบบฮาร์โมนา이즈 (Harmonized System: HS) ฉบับปี ๒๐๑๗ เป็นฉบับปี ๒๐๒๒ ภายใต้ความตกลงว่าด้วยการค้าสินค้าภายใต้กรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจที่ครอบคลุมด้านต่าง ๆ ระหว่างรัฐบาลแห่งกลุ่มประเทศสมาชิกสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้และสาธารณรัฐเกาหลี (The Agreement on Trade in Goods under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea: AKFTA) นั้น

เพื่อให้การออกหนังสือรับรองถิ่นกำเนิดสินค้าตามความตกลง AKFTA รองรับการมีผลบังคับใช้ของ PSRs HS ๒๐๒๒ ตั้งแต่วันที่ ๑ พฤษภาคม พ.ศ. ๒๕๖๙ เป็นต้นไป และเป็นไปตามความในข้อ ๓ ของประกาศกระทรวงพาณิชย์ เรื่อง การออกหนังสือรับรองถิ่นกำเนิดสินค้าตามความตกลงทางการค้าระหว่างประเทศหรือการปฏิบัติทางการค้าระหว่างประเทศ พ.ศ. ๒๕๕๘ อธิบดีกรมการค้าต่างประเทศจึงออกประกาศไว้ ดังต่อไปนี้

ข้อ ๑ ประกาศนี้ให้ใช้บังคับตั้งแต่วันที่ ๑ พฤษภาคม พ.ศ. ๒๕๖๙ เป็นต้นไป

ข้อ ๒ ให้ยกเลิกประกาศกรมการค้าต่างประเทศ เรื่อง การออกหนังสือรับรองถิ่นกำเนิดสินค้า ตามความตกลงว่าด้วยการค้าสินค้าภายใต้กรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจ ที่ครอบคลุมด้านต่าง ๆ ระหว่างรัฐบาลแห่งกลุ่มประเทศสมาชิกสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้ และสาธารณรัฐเกาหลี พ.ศ. ๒๕๕๘ ลงวันที่ ๒๒ ธันวาคม พ.ศ. ๒๕๕๘

ข้อ ๓ ในประกาศนี้

“ความตกลง AKFTA” หมายความว่า ความตกลงว่าด้วยการค้าสินค้าภายใต้กรอบความตกลงว่าด้วยความร่วมมือทางเศรษฐกิจที่ครอบคลุมด้านต่าง ๆ ระหว่างรัฐบาลแห่งกลุ่มประเทศสมาชิกสมาคมประชาชาติแห่งเอเชียตะวันออกเฉียงใต้และสาธารณรัฐเกาหลี (The Agreement on Trade in Goods under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea: AKFTA)

“หนังสือรับรองถิ่นกำเนิดสินค้า” หมายความว่า หนังสือรับรองถิ่นกำเนิดสินค้าตามความตกลง AKFTA (Form AK) ตามภาคผนวก ก ท้ายประกาศนี้

ข้อ ๔ ให้ผู้ส่งออกสินค้าที่มีถิ่นกำเนิดในประเทศไทยที่มีความประสงค์จะขอหนังสือรับรองถิ่นกำเนิดสินค้าเพื่อนำไปแสดงประกอบการใช้สิทธิพิเศษทางภาษีศุลกากรตามความตกลง AKFTA ยื่นคำขอหนังสือรับรองถิ่นกำเนิดสินค้าต่อกรมการค้าต่างประเทศหรือหน่วยงานที่ได้รับมอบหมาย ผ่านระบบการออกหนังสือรับรองถิ่นกำเนิดสินค้าของกรมการค้าต่างประเทศ โดยระบุข้อมูลพร้อมเอกสารหลักฐาน ดังต่อไปนี้

(๑) ใบกำกับสินค้า (Invoice)

(๒) ใบตราส่งสินค้าทางเรือ (Bill of Lading) หรือใบตราส่งสินค้าทางอากาศ (Air Waybill) หรือเอกสารหลักฐานอื่นที่แสดงการขนส่งสินค้าระหว่างประเทศ

(๓) เอกสารหลักฐานแสดงการตรวจคุณสมบัติทางด้านถิ่นกำเนิดของสินค้าเกษตร หรือ สินค้าอุตสาหกรรม แล้วแต่กรณี ตามกฎว่าด้วยถิ่นกำเนิดสินค้าและระเบียบปฏิบัติเกี่ยวกับการรับรองถิ่นกำเนิดสินค้า รวมทั้งข้อกำหนดเพิ่มเติมภายใต้ความตกลง AKFTA โดยให้ดำเนินการ ดังนี้

(ก) กรณีสินค้าเกษตร (พิกัดอัตราศุลกากรตอนที่ ๐๑ ถึงตอนที่ ๒๔) ให้ยื่นแบบขอรับการตรวจคุณสมบัติของสินค้าทางด้านถิ่นกำเนิดเพื่อขอใช้สิทธิพิเศษทางด้านภาษีศุลกากร ท้ายประกาศกรมการค้าต่างประเทศ เรื่อง การตรวจคุณสมบัติของสินค้าทางด้านถิ่นกำเนิดที่จะขอใช้สิทธิพิเศษทางด้านภาษีศุลกากร พ.ศ. ๒๕๖๒ ลงวันที่ ๑๑ กรกฎาคม พ.ศ. ๒๕๖๒ ในขณะที่ยื่นขอหนังสือรับรองถิ่นกำเนิดสินค้า

(ข) กรณีสินค้าอุตสาหกรรม (พิกัดอัตราศุลกากรตอนที่ ๒๕ ถึงตอนที่ ๙๗) ให้ระบุข้อมูลที่ปรากฏในผลการตรวจคุณสมบัติของสินค้าทางด้านถิ่นกำเนิดตามที่กรมการค้าต่างประเทศ หรือหน่วยงานที่ได้รับมอบหมายได้รับรองผลแล้วในระบบอิเล็กทรอนิกส์ของกรมการค้าต่างประเทศ

(๔) เอกสารหลักฐานอื่นที่เกี่ยวข้องเพื่อให้สอดคล้องกับกฎว่าด้วยถิ่นกำเนิดสินค้าและระเบียบปฏิบัติเกี่ยวกับการรับรองถิ่นกำเนิดสินค้า รวมทั้งข้อกำหนดเพิ่มเติมภายใต้ความตกลง AKFTA

ข้อ ๕ กรณีจำเป็นต่อการพิสูจน์ถิ่นกำเนิดสินค้า กรมการค้าต่างประเทศหรือหน่วยงานที่ได้รับมอบหมายมีอำนาจเรียกเอกสารหลักฐานที่เกี่ยวข้องกับการแสดงถิ่นกำเนิดสินค้าเพิ่มเติมได้ตามที่เห็นสมควร

ข้อ ๖ หนังสือรับรองถิ่นกำเนิดสินค้าให้มีอายุ ๑๒ เดือน นับแต่วันที่ออก

ข้อ ๗ ระยะเวลาการยื่นคำขอหนังสือรับรองถิ่นกำเนิดสินค้า

(๑) ให้ผู้ส่งออกยื่นคำขอหนังสือรับรองถิ่นกำเนิดสินค้า ก่อนหรือภายในวันที่ส่งออกหรือไม่เกิน ๓ วันทำการ นับแต่วันที่ส่งออก

(๒) กรณีมิได้ดำเนินการตาม (๑) ให้ผู้ส่งออกยื่นคำขอหนังสือรับรองถิ่นกำเนิดสินค้าต่อกรมการค้าต่างประเทศหรือหน่วยงานที่ได้รับมอบหมายภายในระยะเวลาไม่เกิน ๑ ปี นับแต่วันที่ส่งออก โดยกรมการค้าต่างประเทศหรือหน่วยงานที่ได้รับมอบหมายจะระบุข้อความ “ISSUED RETROACTIVELY” ในหนังสือรับรองถิ่นกำเนิดสินค้า

ข้อ ๘ ให้ระบุเกณฑ์ถิ่นกำเนิดสินค้าในข้อ ๘ ของหนังสือรับรองถิ่นกำเนิดสินค้า โดยต้องเป็นไปตามหลักเกณฑ์การได้ถิ่นกำเนิดสินค้าตามภาคผนวก ๓ กฎว่าด้วยถิ่นกำเนิดสินค้าภายใต้ความตกลง AKFTA ดังต่อไปนี้

(๑) กรณีใช้เกณฑ์ถิ่นกำเนิดสินค้าที่ได้มาหรือผลิตขึ้นทั้งหมดในประเทศผู้ส่งออก (Wholly obtained or produced entirely in the territory of the exporting Party) ให้ระบุ “WO”

(๒) กรณีใช้เกณฑ์ถิ่นกำเนิดสินค้าการเปลี่ยนแปลงอัตราศุลกากรในระดับ ๔ หลัก (Change in Tariff Heading: CTH) ให้ระบุ “CTH” หรือกรณีใช้เกณฑ์สัดส่วนมูลค่าการผลิตในภูมิภาค (Regional Value Content: RVC) ที่กำหนดให้มีถิ่นกำเนิดจากประเทศสมาชิกผู้ส่งออกไม่น้อยกว่าร้อยละ ๔๐ ของราคา เอฟ โอ บี (Free - on - Board: FOB) ของสินค้าที่ส่งออก ให้ระบุ “RVC ๔๐%”

(๓) กรณีใช้กฎเฉพาะรายสินค้า (Product Specific Rules: PSRs) ให้ระบุเกณฑ์การได้ถิ่นกำเนิดสินค้าอย่างใดอย่างหนึ่ง ตามภาคผนวก ข ท้ายประกาศนี้ ดังต่อไปนี้

(ก) กรณีใช้เกณฑ์การเปลี่ยนแปลงอัตราศุลกากร (Change in Tariff Classification: CTC) ให้ระบุ “CTC”

(ข) กรณีการได้มาทั้งหมดหรือมีการผลิตทั้งหมดในอาณาเขตของประเทศภาคีสมาชิกใด ๆ (Wholly Obtained or Produced in the Territory of any Party) ให้ระบุ “WO-AK”

(ค) กรณีใช้เกณฑ์สัดส่วนมูลค่าการผลิตในภูมิภาค (Regional Value Content: RVC) ที่กำหนดให้มีถิ่นกำเนิดจากประเทศสมาชิกผู้ส่งออกไม่น้อยกว่าร้อยละ ๔๐ ของราคา เอฟ โอ บี (FOB) ของสินค้าที่ส่งออก ให้ระบุร้อยละที่แท้จริงของสัดส่วนมูลค่าการผลิตในภูมิภาค เช่น “RVC ๔๕%”

(ง) เกณฑ์สัดส่วนมูลค่าการผลิตในภูมิภาค (RVC) ร่วมกับเกณฑ์การเปลี่ยนพิกัดอัตราศุลกากร (CTC) ให้ระบุร้อยละที่แท้จริงของสัดส่วนมูลค่าการผลิตในภูมิภาคร่วมกับเกณฑ์การเปลี่ยนพิกัดอัตราศุลกากรที่แท้จริง เช่น “CTH+RVC ๔๐%”

(จ) กรณีใช้เกณฑ์กระบวนการผลิตเฉพาะ (Specific Processes) ให้ระบุ “Specific Processes”

ข้อ ๙ ให้ระบุน้ำหนักรวมสินค้า (Gross Weight) หรือปริมาณของสินค้าที่ส่งออก ในช่อง ๙ ของหนังสือรับรองถิ่นกำเนิดสินค้า ทั้งนี้ ในกรณีสินค้าผลิตขึ้นตามหลักเกณฑ์สัดส่วนมูลค่าการผลิตในภูมิภาค (Regional Value Content: RVC) ให้ระบุมูลค่า เอฟ โอ บี (FOB) ของสินค้าที่ส่งออกด้วย

ข้อ ๑๐ ผู้ส่งออกที่ได้นำเข้าสินค้าจากประเทศภาคีสมาชิกเพื่อส่งออกไปยังประเทศภาคีสมาชิกใดสมาชิกหนึ่ง และมีความประสงค์จะขอหนังสือรับรองถิ่นกำเนิดสินค้า รูปแบบ Back-to-Back ให้ปฏิบัติตามหลักเกณฑ์ ดังต่อไปนี้

(๑) สินค้าที่นำเข้ามาเพื่อส่งออกโดยใช้หนังสือรับรองถิ่นกำเนิดสินค้า รูปแบบ Back-to-Back จะต้องไม่ผ่านกระบวนการใด ๆ เพิ่มเติมในประเทศ เว้นแต่เป็นการบรรจุหีบห่อใหม่ กิจกรรมด้านการขนส่ง หรือกระบวนการอื่น ๆ ที่จำเป็นต่อการเก็บรักษาสินค้าให้อยู่ในสภาพดีหรือสำหรับการขนส่งไปยังประเทศภาคีสมาชิกปลายทาง

(๒) แสดงเอกสารหลักฐานประกอบการขอหนังสือรับรองถิ่นกำเนิดสินค้า รูปแบบ Back-to-Back โดยระบุข้อมูลพร้อมจัดส่งเอกสารหลักฐานที่จัดทำขึ้นในรูปแบบข้อมูลอิเล็กทรอนิกส์ผ่านระบบอิเล็กทรอนิกส์ของกรมการค้าต่างประเทศ ดังนี้

(ก) หนังสือรับรองถิ่นกำเนิดสินค้าจากประเทศภาคีสมาชิกต้นทางที่ยังไม่หมดอายุ

(ข) ใบกำกับสินค้า (Invoice) ที่ใช้ในการนำเข้าและส่งออก

(ค) ใบตราส่งสินค้าทางเรือ (Bill of Lading) หรือใบตราส่งสินค้าทางอากาศ (Air Waybill) หรือเอกสารหลักฐานอื่นที่แสดงการขนส่งสินค้าระหว่างประเทศที่ใช้ในการนำเข้าและส่งออก

(ง) ใบขนสินค้าขาเข้า

(๓) ระบุเลขที่และวันที่ของหนังสือรับรองถิ่นกำเนิดสินค้าที่ออกโดยประเทศภาคีสมาชิกต้นทางประเทศแรกในช่องที่ ๗ ของหนังสือรับรองถิ่นกำเนิดสินค้า รูปแบบ Back-to-Back

(๔) ให้ทำเครื่องหมาย (✓) หน้าข้อความ “Back-to-Back CO” ในช่อง ๑๓ ของหนังสือรับรองถิ่นกำเนิดสินค้า

หนังสือรับรองถิ่นกำเนิดสินค้า รูปแบบ Back-to-Back ที่กรมการค้าต่างประเทศออกให้ตามวรรคหนึ่ง จะมีวันหมดอายุวันเดียวกันกับหนังสือรับรองถิ่นกำเนิดสินค้าจากประเทศภาคีสมาชิกต้นทาง

ข้อ ๑๑ กรณีผู้ส่งออกมีความประสงค์จะขอหนังสือรับรองถิ่นกำเนิดสินค้าสำหรับสินค้าที่นำไปจัดแสดงในงานจัดแสดงสินค้า (Exhibition) รวมถึงงานแสดงด้านการค้า การเกษตร งานประดิษฐ์ และหัตถกรรม หรืองานในลักษณะเดียวกันที่จัดขึ้นเพื่อแสดงสินค้าด้วยวัตถุประสงค์ในการขายสินค้าในต่างประเทศ ณ ประเทศภาคีสมาชิกอื่น และได้ขายไปในช่วงหรือภายหลังงานจัดแสดงสินค้า ได้สิ้นสุดลง เพื่อนำเข้าไปยังประเทศภาคีสมาชิกใดสมาชิกหนึ่ง ให้ปฏิบัติตามหลักเกณฑ์ ดังต่อไปนี้

(๑) ทำเครื่องหมาย (✓) หน้าข้อความ “Exhibition” ในช่อง ๑๓ และระบุชื่อและที่อยู่ของสถานที่จัดงานแสดงสินค้า ในช่อง ๒ ของหนังสือรับรองถิ่นกำเนิดสินค้า

(๒) สินค้านั้นจะต้องอยู่ภายใต้การควบคุมดูแลของหน่วยงานศุลกากรประเทศภาคีสมาชิกที่จัดงานแสดงสินค้านั้นในระหว่างงานแสดงสินค้า

(๓) สินค้านั้นจะต้องขาย หรือโอน ให้แก่ผู้นำเข้าในประเทศภาคีสมาชิกใดสมาชิกหนึ่ง ในระหว่างงานแสดงสินค้าหรือทันทีหลังจากงานแสดงสินค้าสิ้นสุดลง และสินค้ายังคงอยู่ในสภาพเดิมที่ถูกส่งไปจัดแสดง

ข้อ ๑๒ การยื่นขอหนังสือรับรองถิ่นกำเนิดสินค้า กรณีที่ใบกำกับสินค้า (Invoice) ออกโดยบริษัทที่ตั้งอยู่ในประเทศที่สาม (Third Country Invoicing) หรือโดยผู้ส่งออกที่เป็นตัวแทนของบริษัทดังกล่าว ให้ปฏิบัติตามหลักเกณฑ์ ดังต่อไปนี้

(๑) ทำเครื่องหมาย (✓) หน้าข้อความ “Third Country Invoicing” ในช่อง ๑๓ ของหนังสือรับรองถิ่นกำเนิดสินค้า

(๒) ระบุชื่อและประเทศของบริษัทที่ตั้งอยู่ในประเทศที่สามหรือผู้ส่งออกที่เป็นตัวแทนของบริษัทดังกล่าว ในช่อง ๗ ของหนังสือรับรองถิ่นกำเนิดสินค้า

(๓) ให้ระบุเลขที่และวันที่ของใบกำกับสินค้า (Invoice) ที่ออกโดยบริษัทที่ตั้งอยู่ในประเทศที่สาม หรือผู้ส่งออกที่เป็นตัวแทนของบริษัทดังกล่าวในช่อง ๑๐ ของหนังสือรับรองถิ่นกำเนิดสินค้า

ข้อ ๑๓ กรณีหนังสือรับรองถิ่นกำเนิดสินค้าถูกโจรกรรม สูญหาย หรือชำรุดเสียหาย ให้ผู้ส่งออกรื่นคำขอหนังสือรับรองถิ่นกำเนิดสินค้าต่อกรมการค้าต่างประเทศหรือหน่วยงานที่ได้รับมอบหมาย ภายใน ๑ ปี นับแต่วันที่ออกหนังสือรับรองถิ่นกำเนิดสินค้า ซึ่งกรมการค้าต่างประเทศหรือหน่วยงานที่ได้รับมอบหมายจะออกหนังสือรับรองถิ่นกำเนิดสินค้าฉบับทดแทน โดยระบุเลขที่และวันที่ออกหนังสือรับรองถิ่นกำเนิดสินค้าฉบับเดิม พร้อมทั้งระบุข้อความ “CERTIFIED TRUE COPY” ในช่อง ๑๒ ของหนังสือรับรองถิ่นกำเนิดสินค้าฉบับทดแทน ทั้งนี้ หนังสือรับรองถิ่นกำเนิดสินค้าฉบับทดแทนจะมีอายุใช้ได้ไม่เกินกำหนดวันหมดอายุของหนังสือรับรองถิ่นกำเนิดสินค้าฉบับเดิม

ข้อ ๑๔ ผู้ผลิตหรือผู้ส่งออกที่ยื่นขอหนังสือรับรองถิ่นกำเนิดสินค้าต้องเก็บรักษาเอกสารหลักฐานที่ใช้ประกอบการยื่นขอหนังสือรับรองถิ่นกำเนิดสินค้าไม่น้อยกว่า ๓ ปี นับแต่วันที่ออกหนังสือรับรองถิ่นกำเนิดสินค้าในแต่ละฉบับ

2. CONDITIONS: To enjoy preferential tariff under the AKFTA, goods sent to any Parties listed above:

- (i) must fall within a description of goods eligible for concessions in the country of destination;
- (ii) must comply with the consignment conditions in accordance with Rule 9 of Annex 3 (Rules of Origin) of the AKFTA; and
- (iii) must comply with the origin criteria in Annex 3 (Rules of Origin) of the AKFTA.

3. ORIGIN CRITERIA: For goods that meet the origin criteria, the exporter and/or producer must indicate in box 8 of this Form, the origin criteria met, in the manner shown in the following table:

4. EACH ARTICLE MUST QUALIFY: It should be noted that all the goods in a consignment must qualify separately in their own right. This is of particular relevance when similar articles of different sizes or spare parts are sent.

5. DESCRIPTION OF GOODS: The description of goods must be sufficiently detailed to enable the goods to be identified by the Customs Officers examining them. Any trade mark shall also be specified.

6. FREE-ON-BOARD (FOB) VALUE: The FOB value in Box 9 shall be reflected only when the Regional Value Content criterion is applied in determining the origin of goods. The CO (Form AK) issued to and from Cambodia and Myanmar shall reflect the FOB value, regardless of the origin criteria used, for the next two (2) years upon the implementation of this new arrangement.

7. HARMONIZED SYSTEM NUMBER: The Harmonized System number shall be that of the importing Party.

8. EXPORTER: The term “Exporter” in box 11 may include the manufacturer or the producer.

9. FOR OFFICIAL USE: The Customs Authority of the importing Party must indicate (√) in the relevant boxes in column 4 whether or not preferential tariff is accorded.

10. THIRD COUNTRY INVOICING: In cases where invoices are issued by a third country, the “Third Country Invoicing” box should be ticked (√) and such informations as name and country of the company issuing the invoice shall be indicated in box 7.

11. EXHIBITIONS: In cases where goods are sent from the territory of the exporting Party for exhibition in another country and sold during or after the exhibition for importation into the territory of a Party, in accordance with Rule 20 of the Operational Certification Procedures, the “Exhibitions” box should be ticked (√) and the name and address of the exhibition indicated in box 2.

12. BACK-TO-BACK CERTIFICATE OF ORIGIN: In cases of Back-to-Back CO, in accordance with Rule 7 (2) of the Operational Certification Procedures, the “Back-to-Back CO” box should be ticked (√).
